Foreword

This report on Progress of Arab Women, commissioned by UNIFEM's regional office in Amman, Jordan, comes at a critical moment. As discussion on economic and political reform in the region intensifies, propelled by the recognition that economic prosperity depends upon more inclusive societies, so too has the discussion of women's status. For while the promotion of women's rights is strongly resisted in many quarters, it is increasingly widely recognized by scholars and political reformers both within and outside of the region, that democracy, development and peace all require progress in advancing the status of women.



The report follows the framework of UNIFEM's biennial report, Progress of the World's Women, in evaluating women's progress along a number of critical indicators. It also monitors the implementation of commitments made in the Beijing Platform for Action in 1995 and of the Convention on the Elimination of all Forms of Discrimination Against Women. It departs from other reports, however, in that instead of comparing the status of Arab women to that of women in other countries and regions, it situates its analysis of women's status in a historical, political, ideological and social context. It examines the forces of economic globalization that are propelling the move towards change in different countries in the region as well as the geopolitical dynamics that continue to create political obstacles to change. It also highlights a UNIFEM conviction that supporting women's economic security presents an essential and viable platform for their participation in the political arena.

The other thing that distinguishes this study is that throughout, it presents its findings and analysis from the perspective of women themselves. It starts from the premise that in order for women to achieve effective social, economic and political participation, the factors that perpetuate and sustain their exclusion at all levels of decision-making must be addressed. In that sense, this report avoids a view of gender equality as merely one item on a check list to looking at its potential for social transformation.

We congratulate all who contributed to this timely report. Their dedication and commitment to moving the agenda forward should be an important addition to the current domestic, regional and global discussion on the role of Arab women in economic and political change in the region.
